Personal precautions, protective equipment and emergency procedures Wear protective equipment. Dispose contaminated material as waste according to item 13. Ensure adequate ventilation. Do not flush with water or aqueous cleansing agents Contain and collect spillages with non-combustible absorbent materials (e.g. sand, earth, diatomaceous earth) and place in a suitable container. Decontaminate immediately with suitable mixture (flammable): - as such usable (inflammatory!): 45 Vol.% water 50 Vol.% ethanol or isopropanol ammonia solution (Density= 0.88) 5 Vol.% - alternatively (non-flammable): sodium carbonate 5 Vol.% 95 Vol.% water

Add the same decontaminant to any residues and allow to stand for several days in an non-sealed container until no further reaction occurs. Once this stage is reached, close the container and dispose of in accordance with the waste regulations (see Section 13).
